The IRS is providing only Forms 1040, 1040EZ and 1040A to libraries for distribution this year and will only provide one reproducible copy of the instruction booklets and other forms. For your convenience, the Dayton Metro Library has prepared and printed a booklet of the most common IRS instructions, available for one-week checkout.

## FREE TAX RETURN PREPARATION FOR QUALIFYING TAXPAYERS

**The Volunteer Income Tax Assistance (VITA)** program offers free tax help to people who generally make \$53,000 or less, persons with disabilities, the elderly, and limited English speaking taxpayers who need assistance in preparing their own tax returns. IRS-certified volunteers provide free basic income tax return preparation with electronic filing to qualified individuals. Local VITA sites are listed on the reverse or call the IRS toll-free at 800-906-9887.
